## Our aims and objectives:

*We aim to:*

- Provide an excellent, internationally recognised expert pre-travel health advice and vaccination service to all those who use our clinics.
- Offer high standards of customer care, where all clients are treated with respect and courtesy.
- Treat all clients safely, using the most up to date country-specific clinical advice.

*Objectives:*

- To provide advice for planning an overseas trip, giving everyday precautions and country-specific recommendations to minimise health risks associated with travel.
- To provide additional specialist services to people who are travelling abroad for work, including pre-travel medicals, post travel screening services and medical screening for visa purposes.
- To provide risk assessment and vaccination services for clients who have vaccinations for both occupational and personal reasons.

## What specific services do we offer?

- Pre-travel risk assessment
- Advice, vaccinations, malaria tablets and a range of pre and post travel diagnostic tests (including Mantoux tests and Covid-19 swabs)
- Occupational vaccination for UK-based workers
- Pre-deployment occupational health medicals
- Specialist OGUK and MCA medicals and medical screening for visa purposes
- Post-travel occupational health screening and check-ups
- Telephone advice and support regarding tropical/travel health for occupational health and other specialist units
- Other types of vaccination (such as flu and cervical cancer vaccination)
- A range of travel health products

As part of unique links with the National Health Service, we also provide:

- Post-exposure rabies vaccination service
- Emergency malaria screening service

## Who can access our services?

We offer services to all those who require them, and for both adults and children.

We are also able to offer travel vaccination services to travellers with special needs, such as pregnant and breast-feeding women, and to travellers with pre-existing medical problems.
